- 1 Mapletree Logistics Trust Management Ltd., as manager of Mapletree Logistics Trust ("MapletreeLog", and manager of MapletreeLog, the "Manager"), is pleased to announce the completion of the acquisition of Tang Logistics Centre at 10 Changi South Street 3 Singapore 486147 (the "Property") today for a purchase price of S\$20.0 million.
- 2 HSBC Institutional Trust Services (Singapore) Limited, as trustee of MapletreeLog (the "Trustee"), has today exercised the call option under the put and call option agreement (the "Option Agreement") entered into between Tang Logistics Centre Pte. Ltd. ("Tang Logistics") and the Trustee, in connection with the sale and purchase of the Property, on 12 December 2005.
- 3 Pursuant to the Trustee's exercise of the call option under the Option Agreement, the Trustee and Tang Logistics has today entered into the sale and purchase agreement for the Property.
- 4 The purchase price and other acquisition costs of the Property are fully funded by the net proceeds from the issue of new units under the equity fund raising exercise of MapletreeLog, which was completed on 26 January 2006.
- 5 In relation to the initial public offering of MapletreeLog, the joint financial advisers, underwriters and bookrunners were DBS Bank and UBS AG, acting through its business group, UBS Investment Bank.
