- 3 Pursuant to the Trustee's exercise of the call option under the Option Agreement, the Trustee and Popular has today entered into the sale and purchase agreement for the Property.
- 4 The purchase price and other acquisition costs of the Property are fully funded by the net proceeds from the issue of new units under the equity fund raising exercise of MapletreeLog, which was completed on 26 January 2006.
- 5 In relation to the initial public offering of MapletreeLog, the joint financial advisers, underwriters and bookrunners were DBS Bank and UBS AG, acting through its business group, UBS Investment Bank.
