("Citi") pursuant to a borrowing notice dated 30 September 2010 delivered by Citi ("Borrowing Notice") under the unit lending agreement dated 21 September 2010 between Meranti and Citi ("Unit Lending Agreement").</p> <p>Pursuant to the proposed equity fund raising exercise undertaken by MLT comprising the issue of 207,310,000 new Units by way of a private placement ("Private Placement") and 164,345,224 new Units by way of a preferential offering ("Preferential Offering") subject to the terms and conditions of the placement agreement dated 21 September 2010 between Mapletree Logistics Trust Management Ltd. as the manager of MLT and Citi as sole bookrunner and underwriter, Meranti (as lender) entered into the Unit Lending Agreement with Citi (as borrower) pursuant to which Meranti agreed to lend Citi up to 207,317,073 Units (the "Loan Units") to facilitate the Private Placement. Citi is expected to return the Loan Units upon completion of the Private Placement.</p> |
