PROPOSED DIVESTMENT OF A PROPERTY IN MALAYSIA

Singapore, 7 August 2023 – Mapletree Logistics Trust Management Ltd., as manager (the "Manager") of Mapletree Logistics Trust ("MLT" or the "Trust"), would like to announce that HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of MLT) has, through its special purpose vehicle in Malaysia, entered into a Sale and Purchase Agreement with an unrelated third party for the proposed divestment of Century in Malaysia ("the Property") at a sale price of MYR60.0 million.

Located at Pandamaran, Klang, Selangor, the Property is a 17-year old industrial building comprising two blocks of single-storey warehouse with a gross floor area of 27,878 square metres ("sqm"). The proposed divestment is in line with the Manager's strategy to rejuvenate the portfolio through selective divestments of non-core assets, providing MLT with greater financial flexibility to pursue higher yielding investment opportunities.

The sale price of MYR60.0 million is 15.4% above the latest valuation of MYR52.0 million as at 31 March 2023. In accordance with MLT's Trust Deed, there will be a one-off disposal fee at 0.5% of the sale price payable to the Manager. The Manager has elected to waive the 0.5% fee for this transaction.

The proposed divestment is expected to be completed by FY23/24. It is not expected to have a material impact on MLT's net asset value and net property income for FY23/24. Following the divestment, MLT's portfolio will consist of 190 properties¹.
