ELCHEMI ASSETS PTE LTD AND GUARANTOR)**

Mapletree Logistics Trust Management Ltd., as manager ("**Manager**") of Mapletree Logistics Trust ("**MapletreeLog**"), wishes to announce that MapletreeLog has filed a Bankruptcy Petition (B225/2010/J) against Mr. Ang Chee Seng (guarantor and company director of Elchemi Assets Pte Ltd, the former tenant at 9 Tampines Street 92 Singapore 528871 ("**Property**")) for defaulting on the terms and conditions of the lease agreement on the Property. The Bankruptcy Petition will be heard on 4 March 2010. In this regard, MapletreeLog has obtained summary judgment against the former tenant and the said Mr. Ang Chee Seng, which matter (High Court Suit 740/2009/G) is now under appeal to be heard on 11 February 2010.

The Property comprises a 2-storey warehouse with an ancillary office. It is situated at the eastern part of Singapore with easy accessibility via the Pan Island Expressway and the East Coast Parkway. With a net lettable area of 11,089 sqm, the Property accounts for about 0.5% of MapletreeLog's portfolio total net lettable area as at 31 December 2009.

The Manager has repossessed the Property and is actively marketing the Property for lease. The Manager will take necessary actions to mitigate MapletreeLog's risk exposure.
