Post completion of the private placement and preferential offering, Mapletree Investments Pte Ltd ("MIPL") through its subsidiaries holds 983,085,807 units representing approximately 40.52% of the total number of 2,425,970,525 units in issue. DBS Group Holdings Limited ("DBSH") and Keppel Corporation Limited ("KCL") through their subsidiaries have interests in 5,209,000 units and 386,640 units representing approximately 0.21% and 0.02% respectively of the total number of 2,425,970,525 units in issue. As MIPL is a subsidiary, and DBSH and KCL are associated companies of Temasek, Temasek has a deemed interest in an aggregate of 988,681,447 units representing approximately 40.75% of the total number of 2,425,970,525 units in issue being all of the 983,085,807 units, 5,209,000 units and 386,640 units in MIPL, DBSH and KCL through their subsidiaries have interests. Temasek become aware of the change in the percentage level of its interest in the units on 18 October 2010. |
