On 12 November 2010, Mapletree Logistics Trust Management Ltd., as manager of Mapletree Logistics Trust ("Manager") announced that 347,441 new units in Mapletree Logistics Trust ("Units") had been issued to the Manager as full payment of acquisition fees in respect of certain acquisitions from its sponsor, Mapletree Investments Pte Ltd ("Sponsor"). As the Manager is a subsidiary of the Sponsor, the issue of the 347,441 new Units has increased the deemed interests of the Sponsor to 983,433,248 Units (\*\*40.53%) as at 18 August 2011.

The Sponsor is an indirect wholly owned subsidiary of Temasek Holdings (Private) Limited ("Temasek"). Hence, the deemed interest of Temasek through the Sponsor has increased to 983,433,248 Units (\*\*40.53%) as at 18 August 2011.

An indirect subsidiary of Temasek, Aetos Security Management Pte Ltd ("Aetos") has purchased 300,000 Units (\*\*0.01%). Hence, Temasek has acquired a deemed interest through Aetos in 300,000 Units (\*\*0.01%) as at 18 August 2011.

There has been a series of transactions by subsidiaries of DBS Group Holdings Ltd ("DBSH") which has caused an increase in DBSH's interest to 11,079,000 Units (\*\*0.46%) as at 18 August 2011.

DBSH is an associated company of Temasek. Hence, Temasek's deemed interest through DBSH has increased to 11,079,000 Units (\*\*0.46%) as at 18 August 2011.

Accordingly, as at 18 August 2011, there was a change in the percentage level of Temasek's deemed interest to 994,812,248 Units (\*\*41.00%) comprising: i. 300,000 Units (\*\*0.01%) held by Aetos;

ii. 11,079,000 Units (\*\*0.46%) in which DBSH has an interest; and iii. 983,433,248 Units (\*\*40.53%) in which the Sponsor has an interest.

Temasek became aware of the change in the percentage level of its interest in the Units on 22 August 2011.
