Mapletree Logistics Trust Management Ltd., as manager (the “Manager”) of Mapletree Logistics Trust (“MLT”), wishes to announce that it will issue 5,319,296 new units in MLT (“Units”) at an issue price of S\$1.1454 per Unit pursuant to MLT’s distribution reinvestment plan (“DRP”) in respect of MLT’s distribution for the three months ended 30 June 2014 (the “1Q FY14/15 Distribution”) on 29 August 2014.

The new Units will be credited by 29 August 2014 to securities accounts of MLT unitholders (“Unitholders”) who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. on 29 August 2014.
