DESPATCH OF NOTICES OF ELECTION PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 3Q FY14/15 DISTRIBUTION

Further to the Announcements dated 19 January 2015 and 27 January 2015 by Mapletree Logistics Trust Management Ltd., as manager (the "Manager") of Mapletree Logistics Trust ("MLT") in relation to the application of the distribution reinvestment plan ("DRP") to MLT's distribution for the three months ended 31 December 2014 (the "3Q FY14/15 Distribution"), the Manager wishes to announce that the (a) Notices of Election¹ and (b) Tax Declaration Forms² (where applicable) have been despatched to all eligible persons registered as unitholders of MLT ("Eligible Unitholders") in the Depository Register as at 5.00 p.m. on the Books Closure Date of 27 January 2015 and with registered mailing address in Singapore.

Unitholders with registered mailing addresses outside Singapore ("Overseas Unitholders") who did not provide a mailing address in Singapore for the service of notices and documents by notifying The Central Depository (Pte) Limited ("CDP") by 21 January 2015 will not receive the Notices of Election.

Eligible Unitholders who wish to participate in the DRP must complete, sign and return the Notices of Election (and Tax Declaration Forms if applicable) to Boardroom Corporate & Advisory Services Pte. Ltd. (the "Unit Registrar") at 50 Raffles Place, #32-01 Singapore Land Tower, Singapore 048623.

The Notices of Election (and Tax Declaration Forms if applicable) must be received by the Unit Registrar **no later than 5.00 p.m. on 13 February 2015**, and may not be withdrawn or cancelled upon receipt. Notices of Election (and Tax Declaration Forms if applicable) received **after 5.00 p.m. on 13 February 2015 will not be processed**.

The 3Q FY14/15 Distribution will be paid on 27 February 2015. The new units in MLT to be issued under the DRP are expected to be listed on Singapore Exchange Securities Trading Limited on 27 February 2015. Eligible Unitholders who do not elect to participate in the DRP and Overseas Unitholders who did not provide registered mailing addresses in Singapore to CDP will receive all of their respective entitlements to the 3Q FY14/15 Distribution in cash.

² "Tax Declaration Form" means the "Declaration for Singapore Tax Purposes Form A and Form B (and its annexes)" which are sent to all Unitholders except individual Unitholders.
