## ISSUE PRICE OF NEW UNITS TO BE ISSUED PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE BALANCE 1Q FY18/19 DISTRIBUTION

Further to the announcement dated 23 July 2018 by Mapletree Logistics Trust Management Ltd., as manager (the "Manager") of Mapletree Logistics Trust ("MLT") in relation to the application of the distribution reinvestment plan ("DRP") to MLT's distribution for the period from 05 June 2018 to 30 June 2018 (the "Balance 1Q FY18/19 Distribution"), the Manager wishes to announce that the issue price of the new units in MLT ("Units") to be issued under the DRP is S\$1.2476 per Unit.

The issue price represents a 2%¹ discount to the adjusted volume-weighted average traded price² per Unit ("adjusted VWAP") for all trades on Singapore Exchange Securities Trading Limited (the "SGX-ST") during the period of 10 market days prior to and ending on the Books Closure Date ("BCD") of 31 July 2018.

The notice of election is expected to be despatched to all Eligible Unitholders<sup>3</sup> on 6 August 2018 for which an announcement will be issued accordingly.

<sup>&</sup>lt;sup>1</sup> The issue price represents effectively a 2% discount to the volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 market days prior to and ending on the BCD.

The adjusted VWAP is computed based on the volume-weighted average traded price per Unit for all trades on the SGX-ST for each of the market days during the period of 10 market days prior to and ending on the BCD and subtracting the Balance 1Q FY18/19 Distribution of 0.559 cents per Unit for each of the market days prior to the first day of "ex-distribution" trading.
