ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN**

Mapletree Logistics Trust Management Ltd., as manager (the “Manager”) of Mapletree Logistics Trust (“MLT”), wishes to announce that it has issued 9,616,727 new units in MLT (“Units”) at an issue price of S\$1.4365 per Unit pursuant to MLT’s distribution reinvestment plan (“DRP”) in respect of MLT’s distribution for the period from 1 January 2019 to 31 March 2019 (the “4Q FY18/19 Distribution”) on 12 June 2019.

The new Units will be credited by 13 June 2019 to securities accounts of MLT unitholders (“Unitholders”) who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. on 13 June 2019.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issuance of the new Units, the total number of MLT Units has increased from 3,624,984,790 to 3,634,601,517.

Further to the announcements dated 26 April 2019 and 14 May 2019, Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered mailing addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 4Q FY18/19 Distribution in cash on 13 June 2019.
