MAPLETREELOG ACQUIRES 20 TAMPINES STREET 92 FOR S\$10.0 MILLION

Singapore, 11 December 2006 – Mapletree Logistics Trust Management Ltd. (“MLTM”), Manager of Mapletree Logistics Trust (“MapletreeLog”), is pleased to announce that MapletreeLog, through its Trustee, HSBC Institutional Trust Services (Singapore) Limited, has signed a put and call option agreement to purchase a warehouse-cum-office property for S\$10.0 million from SGX-listed Eastgate Technology Ltd. (“Eastgate”).

The property, located at 20 Tampines Street 92, Singapore, has been acquired on a sale and leaseback basis and will be leased back to Eastgate’s wholly-owned subsidiary, Mediagate Pte Ltd (“Mediagate”), for seven years with an option to extend for a further term of seven years.

The acquisition will be accretive to MapletreeLog’s distribution per unit (“DPU”) and the pro forma financial effect of the acquisition on the DPU for the financial year ended 31 December 2005 would be an additional 0.04 Singapore cents per unit¹.

Benefits and rationale of the Acquisition

Mr. Chua Tiow Chye, Chief Executive Officer of MLTM, said, “This acquisition represents our latest expansion of an already significant property portfolio in Singapore, which is one of our core markets. We will therefore continue to pursue accretive acquisitions such as this one to add value and enhance the stability of income to the Trust. In addition, we are also pleased to welcome a well established local name, Mediagate, as our latest lessee in this sale and leaseback deal.”

¹ Assuming that MapletreeLog had purchased, held and operated the subject property for the whole of the financial year ended 31 December 2005 (based on 18 properties) and that the acquisition is fully funded by debt

Eastgate is a manufacturer and distributor of digital storage products in Asia Pacific and it has manufacturing facilities in Singapore, Taiwan and Thailand. Its subsidiary, Mediagate, produces and packages compact discs (CDs) and digital video discs (DVDs) for major customers in the audio and video as well as the information technology industries. Their clients include international brand names such as Adobe, Hewlett Packard, Adaptec, Canon, Microsoft and Apple.

Funding

The acquisition is expected to be completed by February 2007. The Manager is confident that at its completion, MapletreeLog will have sufficient debt capacity to fund the acquisition wholly by debt. However, as part and parcel of the Manager's capital management strategy to optimise the funding of the Trust, the Manager may consider alternative funding options such as the issuance of new units in MapletreeLog to complete this acquisition and/or to refinance the debt taken to complete this acquisition.

General Description of the property

20 Tampines Street 92 comprises a two-storey warehouse facility with an ancillary office and a six-storey annex warehouse facility. It is located within the Tampines Industrial Estate in the eastern part of Singapore and is easily accessible via the Pan-Island Expressway and East Coast Expressway. The area is well served by the public transportation network and urban amenities in the nearby Tampines New Town.

The property has been valued at S\$11.2 million by Chesterton International Property Consultants Pte Ltd as at 6 November 2006. It has a floor area of about 9,251.2 sqm and is located on leasehold land which measures about 6,804.9 sqm. Lease tenure for the land will expire in 2050.
